## Harvey Pro Bono Volunteers! TN Supreme Court calls for #Help4TX

The Tennessee Supreme Court has announced a call to action for "emergency legal responders" to lend a hand to those impacted by Hurricane Harvey. As explained by Chief Justice Bivins at the TALS 2017 Equal Justice University Conference that "Just a few months ago, the Supreme Court issued a call to action for legal assistance across Tennessee called #Help4TNDay, which garnered the equivalent of millions of dollars in free legal assistance. We hope the same will be true for this effort: #Help4TX."

TFJA recognizes that Faith Communities also serve an important role in disaster relief. According to data provided by the National Disaster Interfaiths Network: 60% of people turn first to their religious leaders for advice and direction after a disaster. In August, a Disaster Preparedness Chaplaincy Training was held at Sewanee: University of the South for Faith Leaders interested in learning about disaster relief. We were able to attend part of the training, and learned of many great resources for the TFJA.

Their artists have agreed to partner with TFJA to develop marketing materials for PB&F Days (#PBFDays). Training will be provided on free legal resources available for low-income artists followed by a partnership studio session to collaboratively develop the marketing materials for PB&F Days.
